PROP 65

Proposition 65, also known as The Safe Drinking Water and Toxic Enforcement Act of 1986, is a California law with the initial goal to protect drinking water sources from toxic substances that cause cancer or birth defects and to reduce or eliminate

exposures to those chemicals in consumer products by requiring warnings in advance of those exposures, with the intended goal being that companies choose to reformulate their products without the substances rather than simply providing notice of such substances in their product. These 900+ chemicals are found in our clothing, children's toys, food wrappers, cooking accessories,

furniture finishes... our living world is inundated with cancer causing ingredients.

As a manufacturer, it is our obligation to the living environment and humanity to create products that are free of cancer-causing toxins.

Durato is immensely proud to state that our products do not contain any of the 900+ cancer causing ingredients found on the Proposition 65 list.
